- To achieve a higher level of stakeholder satisfaction, the company prioritizes promoting an accident-prevention mindset and encouraging safety-conscious thinking among its employees, suppliers, subcontractors, and service providers.
- One of our key principles is to minimize improvised work and strive for timely, proper project and high-risk task preparation.
- We aim to ensure the material, personal, and technical conditions required to set occupational health and safety (OHS) goals and meet our and clients' needs.
